The meeting commenced with welcome address by the Chairman, Prof.V.Nandakumar, Head of Department. The syllabi were presented by Prof.M.P.Revathi to the members of board of studies. Then various items of agenda were taken up for discussion and after detailed discussion, the following suggestions were given by the members of board of studies.

- i. In U19CET10 Estimation and Quantity surveying, it is suggested to add the other special structures or substructures such as septic tank and water tank, Rate analysis may be added in course objectives.
- ii. In U19CET10 Estimation and Quantity surveying, in Unit I instead of steel requirement it is asked to mention as Bar bending schedule.

- iii. In U19CET10 Estimation and Quantity surveying, the following topics can be added in Unit –III : 1. Rate analysis for stone masonry, Brick masonry, concreting, painting, plastering, plumbing, Laying of flooring tiles and weather course tiles.
- iv. Text books and Reference books with the recent editions of publication may be added.
- v. In U19CEJ01 Project work Phase-I, the specific design areas need to be added in course objectives like water resource engineering, solid waste management & water pollution and control.
- vi. In Pre-requisites, specifically core subjects only can be added.
- vii. In U19CE02 Project work Phase-II, it is asked to insist the students to publish a paper in conference and journal is mandatory.
- viii. In U19CE02 Project work Phase-II, it is asked to mention the no.of reviews to be conducted and allotment of marks for each review for assessment purpose.

After much deliberation, the following resolutions were passed.

Item 1.1: Resolved to approve the minutes of third Board of Studies meeting held on 10.06.2021

Item 1.2: Resolved to approve the syllabi of seventh and eighth semester for the third year students admitted in the academic year 2019-20 under Regulations 2019.
