The meeting commenced with welcome address by the Chairman, Prof.V.Nandakumar. Then various items of agenda were then taken up for discussion and after detailed discussion, the following suggestions were given by the members of board of studies.

- i. In the 1st semester, Linear Algebra, Calculus and Transforms – to be changed to Linear Algebra and Calculus.
- ii. In the 3rd semester, more importance to be given to Solid Mechanics. Strength of material subject basics are needed for Solid Mechanics lab and hence it has been decided to provide separate lab.
- iii. Surveying has to be kept as theory and practical separately for effective learning.
- iv. For Architectural Planning, students should know building elements. So, only plan, elevation and sectional drawing are to be included in the syllabus.
- v. Structural Analysis I and II should not be combined since the syllabus is vast.
- vi. Internship should be made mandatory after III year. One credit may be given for internship.
- vii. If the student is unable to go for internship in the 7th semester, he/she can go during 6th semester holidays.
- viii. Electives have to be categorized like Structural, Environmental, Transportation, Geotechnical, Construction Management, etc.
- ix. In Construction Materials and Technology, theory has to be in one semester and practical in the next semester.
