- iii. The Courses like Deep Learning, Augmented Reality, Virtual Reality, Human Computer Interaction, Fault Tolerant Computing and Quantum Computing can be included as Professional Electives in the Curriculum.
- iv. The Course Data structures can be moved from Engineering Science to Professional Course.
