









The meeting commenced with welcome address by the Chairman, Prof. S. Gokul. Then various items of agenda were taken up for discussion and after detailed discussion, the following suggestions were given by the members of board of studies.

- i. The courses, Electric Drives and Control, Linear Integrated Circuits and Electric Power Generation Systems shall be included in professional core category.
- ii. Mandatory course (Environmental Science and Indian Constitution) to be included in the scheme under regulation 2019.
- iii. In Professional Elective category, the courses "Simulation of Power Electronic systems" can be introduced and "Principles of Robotics" can be renamed to "Industrial Automation".
- iv. Under Engineering Science category, in Engineering Practices Laboratory, soldering experiments, measurement of electrical energy can be included in the list of experiments.
- v. The content, energy stored in inductor and capacitor, transient analysis can be included in the course "Circuit Analysis".
- vi. The topic, mesh and nodal analysis can be renamed as mesh and nodal techniques in the course "Circuit Analysis".

After much deliberations, the following resolutions were passed.

**Item 1.1: Resolved** to approve the Scheme, Regulation and Syllabi for the final year students admitted during the academic year 2016-17.

**Item 1.2: Resolved** to approve the Scheme, Regulation and syllabi for the second and third-year students admitted during the academic year 2017-18 onwards.

**Item 1.3: Resolved** to approve the Scheme and Regulation for the batch of students to be admitted in the academic year 2019-20 onwards under Regulation 2019.

**Item 1.4: Resolved** to approve the Syllabi for the categories Humanities and Social Sciences (HS), Basic Sciences (BS) and Engineering Sciences (ES) for regulation 2019 under CBCS for the batch of students to be admitted in the academic year 2019-20 onwards.
