- The bloom taxonomy to be consistently maintained throughout the syllabus
- The details of protocol to be followed from the topic selection to the report submission for the MBA project work are to be briefly included in the syllabus.
- Current corporate practices in banking and investment may be included to create knowledge update, citing case examples.
- Managerial relevance is to be given more importance for the new topics like Artificial Intelligence, Machine learning and Industry 4.0
- Since it is mandatory for all Indian Corporate to set aside a definite portion of profit for CSR activities, selected case examples can be included suitably in the syllabus
