- The content of the syllabus may be consistent with the industry expectations and for the PG requirements, this may be considered for 2023 regulation.
- The details of protocol to be followed from the topic selection to the report submission for the MBA project work are to be briefly included in the syllabus and the duration of the project may be mentioned.
- The changes suggested by the members in the syllabus will be carried out.

After detailed discussion, the following resolutions were passed.
