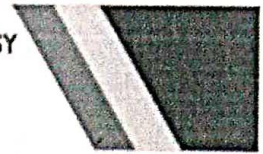



- i. Approval of syllabi for the 3rd and 4th semester for the Regulation 2023 under CBCS for the batch 2023 -2025 of Master of Business Administration (MBA) admitted in the academic year 2023 - 2024.
- ii. Approval of syllabi for third semester and fourth semester under the categories Professional Core (PC), Professional Elective (PE) and Employability Enhancement Course (EEC) under CBCS for the batch of postgraduate MBA students admitted during the academic year 2023 - 2024.
- iii. Approval of Panel of Examiners and Question Paper Setters.

The meeting commenced with introduction by the Chairman, Dr. A. Krishnamurthy, followed by welcome address by Dr. M. Arunmozhi, Associate Professor. The salient features of the syllabus for the third semester and fourth semester were presented for discussion amongst the members. The following suggestions were made:

- The bloom taxonomy to be consistently maintained throughout the syllabus
- Wherever possible the structure and norms of Anna University may be followed pertaining to syllabus upgradation and modifications. The structure may be made flexible to take into account the mode of delivery, student's exposure to current corporate scenario and skill based experiential pedagogy.
- The content of the syllabus may be consistent with the industry expectations and linked with country specific technologies for the PG requirements.
- The changes suggested by the members in the syllabus will be carried out.

Then various items of agenda were taken up for discussion and after detailed discussion, suggestions were incorporated by the members of board of studies.



After much deliberation, the following resolutions were passed.

Item 10.1: Resolved to approve the syllabi for the 3rd and 4th semester for the Regulation 2023 under CBCS for the batch of students admitted in the academic year 2023 – 2024.

Item 10.2: Resolved to approval of syllabi for third semester and fourth semester under the categories Professional Core (PC), Professional Elective (PE) and Employability Enhancement Course (EEC) under CBCS for the batch of postgraduate MBA students admitted during the academic year 2023-2024

Item 10.3: Resolved to approve the list of Examiners and Question Paper Setters.

Revision was made for more than 20% of syllabus change.

Major syllabus changes in the following courses were proposed based on feedback received from stakeholders. The proposed changes were discussed and approved by the BOS members.

Since there were no other points to be discussed. Finally, we closed the meeting with thank note by Dr. S. Priyadharshini, Associate Professor. Next, Chairman thanked all the members of the Board of Studies for their active participation, valuable suggestion and contribution made for recommending the 3rd and 4th semester syllabi.
